版权页：The main focus of the US foreign policy was on its intensified strategic realignment in the Asia-Pacific region in 2011. Although faced with critical diplomatic issues such as the unrest in West Asia and North Africa, the US appeared cautious in its involvement in these issues, avoiding additional burden on itself. At the same time, it was seeking multiple approaches to bringing the two wars to an early end. To beef up its economic growth at home as soon as possible, the US tilted its foreign policy further to the economic field, strengthening coordination with Europe in financial regulation, expediting the process of building the Asia-Pacific trade regime, and consolidating economic and trade relations with Latin America and Africa. I. Intensified Strategic Realignment in the Asia-Pacific Region Since 2011, the United States has further increased its investment of diplomatic and strategic resources in the Asia-Pacific region and to accelerate the comprehensive implementation of strategic realignment in the region. The US made it clear that it would shift its strategic focus to the Asia-Pacific region, which would proceed along six key lines of action: Strengthening bilateral security alliances. Alliances, particularly those with Japan and South Korea, are the fulcrum of the US strategic refocus to the Asia-Pacific. Although some discords occurred in the US-Japan relations because of the impacts of the Fukushima nuclear leakage accident in the first half of 2011, the bilateral alliance was further strengthened during the year. The two countries signed a memorandum of air refueling, allowing Japanese air self-defense force to refuel the US military aircrafts during the joint training exercises and on other relevant occasions, thus making possible two-way mid-air refueling of the US military and Japanese air self-defense force (ASDF) planes, a reverse of the previous practice that the ASDF jets were refueled by the US military planes. The two countries concluded an open skies agreement to enhance the business contacts and people-to-people exchanges. They launched a strategic dialogue on the Asia-Pacific affairs. The US and South Korea continued to develop the capacity of joint operations and increase interoperability. The two countries began to conduct joint researches on missile defense.
