## 章节摘录

版权页 : Article 1 This Law is enacted for the purpose of preventing and controlling water pollution, protecting and improving the environment, guaranteeing drinking water safety, and promoting all-round, balanced, and sustainable development of the economy and society. Article 2 This Law shall be applicable to prevention and control of pollution of rivers, lakes, canals, irrigation channels, reservoirs and other surface water bodies and of ground water bodies within the territory of the People's Republic of China. To prevention and control of pollution of the marine environment, the Marine Environment Protection Law of the People's Republic of China shall be applicable. Article 3 In prevention and control of water pollution, the principles of putting prevention first, combining prevention and control and administering comprehensive treatment shall be followed, priority shall be given to protection of drinking water sources, industrial pollution and pollution by urban household waste shall be kept under strict control, and efforts shall be made to prevent and control agricultural non-point source pollution, promote construction of ecological control projects, and prevent, control and mitigate pollution of the water environment and damage of the ecology. Article 4 People's governments at or above the county level shall incorporate protection of the water environment into their plans for national economic and social development. Local people's governments at or above the county level shall adopt policies and measures to prevent and control water pollution, and take responsibility for the quality of the water environment in their respective administrative areas. Article 5 The State shall introduce the goal responsibility system and assessment system for water environment protection, and make achievement of the goal for water environment protection one of the yardsticks in assessing the performance of local people's governments and their leading persons. Article 6 The State shall encourage and support scientific and technological research on prevention and control of water pollution as well as the wide.
