The Role of Business Research in the Decision-making Process The Nature of Decision Making

Decisions are made by everybody , every day. What do I do today ?
Should I leave , or should I stay ?

Some decisions are explicit , and some are implicit. By inaction , you have made a decision. In other words , success largely depends on what you do and how you do (Of course , a bit of luck in the lottery helps , but that also entail a decision) . The necessity of making decisions often seems to be the only constant of managerial action ; the process , the environment , the individual , and the organization seem to change continually.

Furthermore , the diversity of decision-making activities in organizations is boundless. The same decision maker may use different decision styles at different times ; different makers may not use the same decision style to reach a decision for a particular situation. For example , imagine two managers in an organization , each with a separate problem. One manager must make a decision whether or not to enter a foreign market with a new product ; the other must decide how much raw material to order from a particular supplier. Each decision has a different degree of complexity different informational requirements , and a different time frame.
