## 章节摘录

政府因此转而使用非关税壁垒 (NTB), 如对进口商品确定明确的配额限制。由于此种限制不受市场因素的影响, 可以确切地知道能进口多少商品。遗憾的是, 由于对进口商品的上述限制, 获得进口许可证的商人可能对供不应求的进口货物索要高价, 因而有可能产生垄断利润。

若没有对进口商品的配额限制, 他们就不能总是向公众索价过高。而且他们也会减少消费者自由选择的机会。这些配额从本质上说也会减少世界贸易, 但它们可以刺激经济效率低下地区的生产。

如上所述, 当对进口货物征收关税, 即对价格产生迅速、直接、明显的影响。货物增加的价格可能十分接近于税额。

与此相反, 要预测配额对货物价格的影响就困难得多, 尤其是对那些并不全是境内生产的货物来讲, 结果就更无法确定。

例如, 很多国家并没有自己的汽车工业, 因而进口配额可以引起汽车价格相当大的改变。因此, 关税及非关税壁垒都对世界贸易格局产生巨大的影响。

发达国家传统上都对初级产品保持低关税, 而对半制成品和制成品征收的关税却高得多。这种做法通过限制发展中国家的出口可能性, 阻碍了这些国家加工工业的增长。然而, 这个问题在过去的十年至十五年中取得了最重要的改善, 其中之一就是引进了普惠制 (GSP)。

普惠制规定允许大量的制成品以减免税方式从发展中国家进口到工业国家。

另外还有一些在国际范围内取得的成就。关税与贸易总协定通过长期的努力实现了总的关税税率在一定程度上全面地降低。最近的一次就是众所周知的于1979年结束的东京回合的多边谈判。这些谈判持续了六年, 取得了将在八年内总体上降低工业品关税约30%的成果。

遗憾的是, 关税壁垒降低后, 使用非关税壁垒的趋势就增强了。这两种壁垒毫无疑问都将成为世界各国未来就国际贸易限制问题而进行的谈判中面临的主要问题。
