## 章节摘录

**Commodity Inspection** Commodity inspection is an indispensable link in the chain of smooth handling of foreign trade transactions. Internationally, export and import commodity inspections are executed by a third party generally known as surveyor. Some of the surveyors are governmental organs, others are run by individuals or trade associations. Upon application by the seller or the buyer, the surveyor exercises inspection or analysis over the export or import commodities as to their quality, weight, quantity, packaging, and marking, place of origin or damage. As a result of the inspection and notarized appraisal, commodity inspection certificates are issued. The inspection certificate, in foreign trade practice, functions as foundation or basis on which the delivery and acceptance of the goods, the payment of the goods, or the claim and reimbursement for a loss is made between the seller and the buyer.

In China, the China Import and Export Commodity Inspection and Quarantine Bureau is the main institution authorized to exercise quality, quantity and other kinds of controls over export and import commodities and notarized documents related to foreign trade. The Bureau and its branches act according to state laws and decrees, and work for expanding our foreign trade and safeguarding the country's prestige.

In China, legal inspection of export commodities is conducted on those commodities listed in the "Catalogue of Export and Import Commodities Subject to Inspection", export commodities that require certificates of inspections as stipulated in foreign trade contracts, and animal by-products and foodstuffs for export subject to quarantine and sanitary inspections. According to state regulations, all export commodities listed for legal inspection are subject to examination by a commodity inspection bureau or office on the quality, specifications and packaging conditions as specified in foreign trade contracts or related stipulations. Certificates are issued for those commodities that pass the inspection, and only those with such certificates are allowed to pass through the Customs.
